Priority Area:

REINTEGRATION

Goal 1: District 4 has successful reintegration where services are readily available, timely, in place prior to the juvenile leaving the facility AND increase positive reintegration outcomes for youth in District 4.

Objective A: Increase family engagement/input/knowledge for release back into the community and increase programs such as Family Group Decision Making (FGDM) and Family Preservation referrals to aid in reintegration planning.

Aftercare Team - Convene a group consisting of all service providers who will be involved in client's case upon their release, 90-30 days prior to DJC release, to ensure client knows provider, intake paperwork is complete, and first appointments are scheduled. Utilize funding for qualifying services to avoid any lapse in services. Advocate for this to occur in all four counties in D4. District 4 will reach out to Districts 3 and 5 to compare reintegration/recidivism data and discuss struggles and successes with regard to clients releasing from DJC.
