



Support and resources needed? Detention data supplied by IDJC & IJJC

Indicators to Track and Outcome Measure(s) (How will I know when this task is done):

The R/ED Coordinator will report to the Idaho Juvenile Justice Commission with updated detention data reflecting the findings.

PRIORITY AREA 2: Developing Tribal Assets

GOAL 1: Idaho Tribal Youth will have a voice at Tribal/local, state, and national levels.

Objective 1

Tasks/SMART Goals: (Specific, measurable, action-oriented, realistic, time-limited)

Support Youth Council with each tribe by offering various activities and participating in UNITY and other Youth leadership events.

Responsible person/Owner: TJJC members

Timeframe: Annual

Who else needs to be involved? Tribal community organizations, probation officers

Support and resources needed? Ongoing support from IDJC support staff for funding opportunities, scholarships, and funding education

Indicators to Track and Outcome Measure(s) (How will I know when this task is done): The TJJC will report to the IDJC support staff to report to the Idaho Juvenile Justice Commission for presentation, updates, etc.

Objective 2

Tasks/SMART Goals: (Specific, measurable, action-oriented, realistic, time-limited)

Have youth tribal representation on the IJJC Youth Committee

Responsible person/Owner: TJJC members

Timeframe: Ongoing

Who else needs to be involved? TJJC members, IJJC Youth Committee members, IDJC Support Staff

Support and resources needed? Support from IDJC with promotion materials, meeting assistance, etc.

Indicators to Track and Outcome Measure(s) (How will I know when this task is done): This project is ongoing.

GOAL 2: Youth on the Reservation will have the opportunity to be successful.

Objective 1

Tasks/SMART Goals: (Specific, measurable, action-oriented, realistic, time-limited)

Support cultural activities to reinforce identity, spirituality, and traditional practices.

Responsible person/Owner: TJJC members

Timeframe: Ongoing

Who else needs to be involved? IDJC support staff, probation officers, court officials, tribal communities statewide, tribal community organizations.

Support and resources needed? Support from IDJC on funding procedures and guidelines, community members, potential need for community donations for meals.

Indicators to Track and Outcome Measure(s) (How will I know when this task is done):

This ongoing project may have various activities attached to this goal throughout the next action plan cycle. Activities will be reported to the IDJC support staff and the IJJC members by the TJJC Chair or IDJC staff.
